










#### POSIT Alert Identified Liquidity Executed Volume




#### **POSIT MTF Traded Value by Sector**




#### **POSIT MTF Traded Value by Market Cap**




#### **POSIT EU Traded Value by Market**


# **POSIT EU by Waiver Type**
