MARKET MICROSTRUCTURE OBSERVATIONS

• In January 2023, the average daily volume for TSX listed securities was 663 million shares, down 5% compared to December 2022 and down 18% compared to January 2022. While volatility conditions improved, liquidity and spread conditions were flat compared to December 2022.

• In non-TSX listed securities, the average daily volume was 360 million shares. This was flat vs December 2022 and down 25% compared to January 2022. While spread and volatility conditions improved, liquidity conditions were flat compared to December 2022.

• Dark Venue market share increased significantly compared to December 2022 and set a new 12-month high. Market share growth was most noted in MATCHNow increasing by nearly 0.8% compared to December 2022.• TSX and non-TSX block volumes increased compared to November 2022. Dark venue market share increased slightly compared to November 2022 and Cboe MATCHNow continued to have the largest market share.


New Self-Regulatory Organization of Canada






