MARKET MICROSTRUCTURE OBSERVATIONS

- The average daily volume for TSX listed securities decreased in July 2022 by 17% MoM to 662M shares while up 17% YoY. While liquidity conditions improved MoM, spread and volatility conditions deteriorated and were near the 12-month highs in June.
- Average daily volume for non-TSX listed securities dropped to 250M shares, marking a new 12-month low. YoY, this represents a 47% drop and a 14% drop MoM. While volatility conditions improved, liquidity and spread conditions continued to deteriorate for non-listed TSX securities.
- As TSX Block volumes continued their summer-time decline whereas dark venue market share showed an increase MoM.

Nasdaq Canada Approved to Launch PureStream Order Type on its CXD Trading Book

On 28 July 2022, Nasdaq CXC Limited (operating as Nasdaq Canada) received approval for the launch of the **PureStream** order type on its CXD Trading Book. This new functionality is expected to launch in October 2022.


PureStream orders are paired with one another based on a specific liquidity transfer rate instead of a specific price. The liquidity transfer rate (LTR) indicates the percentage volume of a reference trade that a user is willing to trade. When orders are paired, streams are established which are held by the system until a reference trade occurs. A match is then generated from orders paired in a stream based on their LTR and identified with a unique liquidity marker that will be disseminated in CXD's market data feed. Average Daily Market Volume By Listing Exchange (Shares)




Venue Market Share (TSX-Listed)




Venue Market Share (Non-TSX-Listed)




